

# Call for Speakers LAMP '24

## FAQ

**Question: What topics are appropriate for breakout sessions at LAMP 2024?**

**Answer:** Educational breakout sessions at LAMP should have topics that are interesting and relevant to field leaders and managers or anyone in the financial security profession with recruiting or training responsibilities. Past topics have included recruiting, selection, training, marketing, practice management, technology, and leadership development. Topics can be geared toward aspiring, early career, or seasoned leaders.

**Question: Who can apply through this Call for Speakers?**

**Answer:** Current, practicing field practitioners can apply to speak at LAMP 2024 via this Call for Speakers. Preference is given to current Finseca and GAMA Global members. All others should reach out to Barbara Lecker at [blecker@finseca.org](mailto:blecker@finseca.org).

**Question: What session formats are available?**

**Answer:** All breakout sessions will be 50 minutes in length. We do not have specific formats, rather we want you to focus on the actionable take-aways attendees will have by attending your breakout session. The selection committees will be looking for evidence that your session is relevant to the conference audience and IS NOT a sales pitch for a specific product or service.

**Question: What should I be prepared to answer on this application?**

**Answer:** Be prepared to provide standard contact information and information about your session (draft title, actionable takeaways). You will also need to provide us with your full bio and photo.

You will have the option to provide an example of your speaking ability. Please note that while not required, applications that do not provide a speaking sample will be at a serious disadvantage during the selection process.

**Question: How long will the application take?**

**Answer:** Please allow for 10-45 minutes. How long it takes you to complete the application will depend on how much time you've already spent thinking about the session content.

**Question: Can I submit more than one proposal?**

**Answer:** Yes, but you must submit a new application for each proposal.

**Question: Can I have a co-speaker?**

**Answer:** Yes. There is an option to list one additional speaker in the application.

**Question:** How do I apply to speak on the Mainstage?

**Answer:** Presenting on the Mainstage is by invitation only.

**Question:** What are the benefits of being a breakout speaker at LAMP?

**Answer:** Breakout speakers receive a discount on conference registration, acknowledgment in conference materials, and preferential consideration for additional thought leadership opportunities at Finseca.

**Question:** When will I know if I've been selected, and how much time should I plan to dedicate to the preparation process?

**Answer:** We will contact all applicants by mid-September 2023. All breakout speakers will be required to participate in a 30-minute on-boarding call, participate in one virtual rehearsal session, and submit finalized presentation materials approximately one month prior to the meeting date. **Question:** When are applications due?

**Answer:** All applications must be submitted on August 21, 2023.
